CALL FOR PROPOSALS FOR THE ADJUDICATION OF POOL CLEANING AND MAINTENANCE SERVICES AT THE RESIDENCE OF THIS EMBASSY (ALONIM ST. N. 6, RAMAT GAN, TEL AVIV).

The Embassy of Italy in Tel Aviv issues a call for proposals to provide pool cleaning and regular pool maintenance services at the Residence of this Embassy (Alonim St. n. 6, Ramat Gan, Tel Aviv).

Date and Time

One working day per week.

Minimum time: 1 hour and 30 minutes per working day (= 6 hours per month).

During low-season time (November, December, January, February and March) the cleaning services (and working time) might diminish at the Customer's own discretion. In these circumstances the monthly installments will be reduced and adjusted to the new working schedule proportionately.

Specification of manpower

One professional worker. Hourly wage: at least the minimum wage, as updated according to the Minimum Wage Act.

Duration

The contract will start on January 1, 2020, and will end on December 31, 2021. The possibility of tacit renewal is to be considered excluded.

Recipients

This call for proposals is intended to pool cleaning and maintenance companies that meet the requirements described above, and that have the technical expertise and the financial and human resources to enter such agreement.

Activities

To be performed at no extra cost on regular basis:

- Brush and vacuum the pool
- Backwash filtration system

- Fill the water to its proper level
- Inspect the filtration equipment
- Fill-up the chlorinator with chemical products
- Monitor, test and adjust water to health department standards
- Pool, premise, and plumbing inspections
- Remove and store pool covers (if requested)
- Check equipment and inventory
- Drain and acid cleaning of the pool (once per year, if requested)
- Advise owner of any needed repairs
- Consult on efficiency upgrades or solutions

Equipment

To be provided by the Contractor:

- Telescoping Pole
- Vacuum Heads
- Vacuum Hose
- Leaf Traps
- Vac Plates
- Pool Brushes
- Leaf Bagger

The following activities, not related to ordinary maintenance, will be separately invoiced to the Embassy:

- Pool repairs
- Pool pump motor maintenance/replacement
- Pool filter repairs
- Pool skimmer repairs
- Pool chlorination system repairs
- Scupper maintenance and replacement

Chemical products (chlorine, bromine, algaecide, clarifiers, etc.) and pool filters replacements will be separately invoiced to the Ambassador of Italy.

Work attire will be provided by the Contractor to full-time employees.

Purpose

This call for proposals is aimed to start a constructive dialogue with all interested companies. At this stage, statements of interest shall not be considered as binding. Those submitting statements of interests will not gain preferred placement position in the selection procedure.

Requirements

As a proof of sound business practices in the field of pool cleaning services, companies must include in the statement of interest the following information:

- business license;
- sound business practice in the pool cleaning field in Israel;
- financial statements and business plan.
