CALL FOR EXPRESSION OF INTEREST FOR SURVEILLANCE, STAND CONSTRUCTION AND SETTING-UP SERVICES FOR THE SHOW OF THREE HISTORICAL MASERATI CARS AT TEL AVIV NAMAL

The Embassy of Italy issues a call for expression of interest by service companies interested in providing surveillance, stand construction and setting-up services at Tel Aviv Namal for the exhibition of three historical Maserati cars.

This special event is intended to celebrate and promote the Made in Italy with a free exhibition of three iconic Italian historical Maserati cars in a public area, to show the Israeli citizens the Italian excellency in design, craftsmanship, mechanical production, style and way of life.

Venue

Tel Aviv Namal

Date and Time

11 consecutive days (approximately between the end of May and the end of June). Exact dates TBD.

Recipients

This call for proposals is intended to well-established companies that have the technical expertise and the financial and human resources to enter such agreement. Previous experience with surveillance and stand construction and setting-up services during trade fairs is preferred.

Main activities

- Security (one unarmed security guard, 24/7, 11 consecutive days, Shabbat, weekends and holidays included, rain or shine)
- Stand construction and set-up (the stand shall cover and protect from the weather the three Maserati cars)

- Cars positioning after the arrival at the Namal
- Platform and moquette supply
- Poles and ropes (placed around the cars)
- Lighting
- Audio, amplification and speaker for the opening ceremony
- Full liability insurance (11 days)
- Stand and platform dismantling
- AOB

Equipment

All professional materials, equipment and tools to be provided by the company. Institutional work attire will be provided by the company to all employees.

Purpose

This call is aimed at starting a constructive dialogue with all interested companies. At this stage, statements of interest shall not be considered as binding. Those submitting expressions of interests will not gain preferred placement position in the selection procedure.

Requirements

As a proof of sound business practices, applicants shall provide with the statement of interest the application form (“**A-form**”) and the following information:

- business license;
- company profile;
- letters of reference (if available).

Additional declarations

- Statement that the company has not been declared insolvent in a court and that it does not have any pending legal proceeding;
- Statement of no convictions against the company’s board members for professional misconduct, bankruptcy or any other financial crime;
- Declaration that the company has fulfilled its duties with regard to the payment of taxes, dues, and/or any other mandatory payments, in accordance with current legislation in Israel.
